Sub: Fee Structure of the DNB Trainees for 1st, 2nd & 3rd year of training ...reg

Madam /Sir,

With reference to the subject cited above, I am directed to inform you that as per the latest NBEMS guidelines/Bulletin 2024, the latest Course Fee Structure payable by each DNB trainee per year is as follows:

S. No	Head	Charges (INR) per year
1.	Tuition Fees	75,000
2.	Library Fees	15,000
3.	Annual Appraisal fees	15,000
4.	Accommodation Charges	20,000
Total		1,25,000

The utilization of the course annual fees under the above mentioned 04 heads is as below:

- Tuition fees:** The tuition fees shall cover the cost incurred for accreditation, institutional DNB office, infrastructure and HR, training, teaching & research expenses, guest lecture, thesis support, administrative support expenses.
- Library fees:** Library fees shall cover the provisions made by the hospital for subscription of journals and purchase of textbooks for DNB & FNB trainees.
- Annual appraisal fees:** The appraisal fees shall cover the arrangements made for the purpose of appraisal of trainees and examiner remuneration.
- Accommodation charges:** Electricity and other consumables can be charged on actual basis by the hospital depending upon institutional policy.

Further Annexure II of the NBEMS Guidelines/Bulletin 2024 prescribes details regarding the deposit of the annual course fees by the DNB students (the copy of the same is enclosed for reference purpose).

As such, I am directed to request you for revision of course fees as per the NBEMS Bulletin 2024 as detailed below:

- I. The amount of Rs 1, 25,000 may be applicable for the payment to the Institutions per year by all Ist , 2<sup>nd</sup> & 3<sup>rd</sup> year students of all the DNB Course categories.
- II. The same amount of Rs 1, 25,000 shall be payable by Central/NBEMS category students as well as In Service/BOPEE Category henceforth.

The Course fee is not to be utilized for any other purpose. The accounts of the revenue & expenditure have to be maintained strictly as per financial norms.
