Online application forms are invited from eligible candidates for the engagement of one Peer Supporter/ Educator for Modal Treatment Centre & Treatment Centre under National Viral Hepatitis Control Program (NVHCP) purely on **Voluntary Basis** in GMC Anantnag with honorarium of Rs 10,000/ month.

Terms and Conditions

1. The candidate must be domicile of the District and residing nearby the hospital.
2. The preference shall be given to the person preferably with or recovered from the disease (**Hepatitis "B" or Hepatitis "C"**).
3. The engagement shall be purely on Voluntary basis only and do not confer any right for the selected candidate to the permanent absorption in the department.
4. He/ She shall not be in any Govt. or Semi-Govt. Services, and shall be willing to work voluntary for providing support to people suffering with Hepatitis infection, contact them, call them and motivate them for completion of treatment, for undergoing various tests as per guidelines.
5. This is not to be considered as job, but only as voluntary service with honorarium of **Rs 10,000/-** Per month as incentives.
6. He/ She should have good health condition and able to perform routine duties i.e, office hours.
7. The selected candidate shall have to submit an affidavit to the effect that he/she shall not claim for any regular appointment/extension in the department.
8. Engagement can be terminated at any time by giving short notice, if work and conduct of Peer Educator is not satisfactory and also depends on the approval in the RoP.

Role and Responsibilities of Peer Supporter/ Educator.

1. She / he has to work under the guidance and supervision of Nodal Officer/ Medical Officer.
2. Be the first interface with patient at Centre.
3. Be a peer Educator for patients at Centre and provide Psycho-social support to newly registered patients.
4. Provide assistance to patients enrolled at the Centre, within the hospital OPD & IPD.
5. Discuss the importance of adherence to treatment in need of viral load at 12 weeks post treatment (SVR) with the patients, keep track of drug adherence of patients, counseling them on the importance of regularity of visits and timely investigations.
6. Follow up the patients assist in patient retrieval where necessary & as far as possible.
7. Undertake Data Entry in absence of Data Entry operator.
8. Any other duty related to the initiative assigned by Nodal Officer/ Medical Officer.
