### TERMS AND CONDITIONS:

1. In case the selected candidate(s) fails to join within a period of 21 days from the date of publication of this engagement order, it will be presumed that the said candidate(s) is/are not interested and his/her engagement shall be cancelled ab-initio.
2. If the candidate(s) is/are found guilty of impersonation or submitting fabricated or tampered documents/ testimonials or making statement which are incorrect/false or suppressing material information shall render such person liable for legal action under law and his/her candidature shall be cancelled. In case such a defaulter is traced after selection, his/her contract shall be terminated.
3. The candidate(s) shall have to submit an affidavit duly attested by the Judicial/ 1<sup>st</sup> Class Magistrate to the effect that: -
  - a.
