Pursuant to the recommendation and approval from the selection committee endorsed by the Registrar Academics Govt. Medical College Anantnag and No Objection Certificate issued by the Administrative Department (Health & Medical Education Department) vide No. HD-Gaz0Gen/929/2023-02(E-7354250) dated 21.01.2025, **Dr Raja Ishfaq Rather S/O Ab Gani Rather R/O Dalwach Gagisgund Qazigund**, an in-service candidate, is provisionally engaged as Senior Resident in the Department of General Medicine, Govt. Medical College Anantnag, initially for a period of one year which is extendable upto (03) years on the basis of good performance to be certified by the concerned Head of Department.

### Terms and conditions:

- Before joining the Department, the selected candidate shall submit an undertaking in the office of the Registrar Academics, Govt. Medical College Anantnag duly attested by the Judicial Magistrate (1<sup>st</sup> Class) to the effect that:
  - If the information furnished by me in the application form is found wrong at any point of time, I shall be liable to be punished under rules including confiscation of the Registration of the Doctor.
  - I will not participate in any kind of strike during the period of my tenure engagement. In the event I proceeded on strike, my tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
  - I shall remain disciplined during the tenure period, any kind of misconduct shall make me liable for termination without any prior notice.
  - I am not involved in any criminal activity nor is there is any FIR/Court case pending/registered against me in any criminal department or police station/Hon'ble Court.
  - My engagement is strictly provisional till the recipient of verification of documents/ testimonials and CID Verification. In case adverse report is received from CID, J&K, I shall not claim for engagement which shall be deemed to have been cancelled ab-initio.
  - I shall not claim any Experience Certificate in case I leave Senior Resident-ship before completion of first six months.
  - I will not indulge in any private practice. In case I am found doing private practice my appointment shall be liable for termination without any notice.
- The candidate shall strictly ensure that they shall not leave the Department before the completion of tenure (six months), however abandoning/terminating after six months of the engagement in the specialty will require one-month prior notice on either side falling
