Whereas the candidate Mr. Owais Mushtaq Rather S/O Mushtaq Ahmad Rather R/O Kangan Ganderbal figuring at Sr. No. 1 (OM-1) was selected against the post of Electrician/Line Man for Govt. Medical College Anantnag vide JKSSB No:SSB/SECY/Sel/40/K//2020/2302 dated 13.03.2020 and endorsement letter No. ME/NG/ New / GMC/01/2019 dated 14.04.2020 with his recommendation withheld.

Whereas, the candidature of **Mr. Owais Mushtaq Rather S/O Mushtaq Ahmad Rather R/O Kangan Ganderbal**, was cancelled vide Administrative Department (H&ME) letter No. ME/NG/New/GMC/01/2019 dated 27.04.2021

Whereas, the candidate Mr. Ovais Ahmad Bhat S/O Mohd Rafiq Bhat R/O Putrigam, Mitrigam, Pulwama, figuring at OM-2 Catogary(Waiting List Open Merit), was selected against the post of "Electrician/Lineman" for GMC Anantnag under Advertisement No. 01/2019/041 Division Cadre Kashmir.

Whereas the recommendation of the candidate was kept withheld by JKSSB for want of certain clarifications.

Whereas, case of above candidate has now been re examined in JKSSB. Accordingly withheld recommendation of the above candidate have been released by JKSSB vide No. SSB/ SECY/ SEL/39/ 2020/K/1440-42 dated 16.02.2021 duly endorsed by Health & Medical Education Department vide NO. ME/NG/ New / GMC/01/2019 dated 15/04/2021.

In view of the above, **Mr. Ovais Ahmad Bhat S/O Mohd Rafiq Bhat R/O Putrigam, Mitrigam, Pulwama, figuring at OM-2** Category(Waiting List Open Merit), is appointed as **Electrician/LineMan** (H&ME Department) Division Cadre Kashmir in Govt. Medical College Anantnag in the pay scale of **L-2 (19900-63200).** The appointee is directed to join in Government Medical College Anantnag within a period of 21 days from the date of issuance of appointment order.

The appointment of the candidate shall be subject to the following conditions:

- 1. The candidate, if fails to join within a period of 21 (Twenty one) days from the date of issuance of the appointment order shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- 2. Genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities and recognition of Institutions issuing degree/diploma.
- 3. The appointment of the candidate shall be governed under Jammu & Kashmir Special Recruitment Rules, 2020 notified vide S.O-194 of 2020 dated 17.06.2020 and Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O-192 of 2020 dated 17.06.2020.
- 4. The appointee shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- 5. The interim arrangement, if any, made against the above post be deemed to have been terminated forthwith.
- 6. The appointment in Divisional cadre is non transferable from one Division to another or from one Medical College to another.
- 7. The salary of the appointee shall be drawn and disbursed only after receipt of the satisfactory character/antecedents certificates from Inspector General of Police, CID, J&K and genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
- 8. The appointment of the above candidate is subject to the outcome of the writ petition, if any, pending on the subject in any competent court of jurisdiction.
- 9. The inter seniority of the above appointee shall be as per the merit secured by him in the selection process as indicated against him in the selection list furnished by the J&K Services Selection Board.
- I. The candidate shall give an undertaking in the shape of an Affidavit duly signed by 1st class Magistrate to the effect that:
- II. I will perform my duties to the best satisfaction of the Administration.
- III. I will not participate in any kind of strike/protest or create indiscipline during my tenure in the college/Hospital under any circumstances.
- IV. If the documents submitted by me are found wrong/incorrect at any point of time, my appointment shall be terminated immediately and disciplinary and legal proceedings shall be initiated against me.
- V. In case, if any adverse report about my character/antecedents is received from CID/Police, my appointment shall be deemed to have been cancelled ab-initio.
- VI. I will reside in the vicinity of the GMC Anantnag.

The appointee shall be allowed to join only on production of following documents:

- 3. Domicile Certificate.
- 4. Health Certificate.

- 7. Any other document as required under rules.
