02. If the candidate(s) is found guilty of impersonation or submitting fabricated or tempered documents/ testimonials or making statement which are incorrect/false or suppressing material information shall render such person liable for legal action under law and his/her candidature shall be cancelled. In case such a defaulter is traced after selection, his/her contract shall be terminated.
03. The candidate(s) shall have to submit an affidavit duly attested by the Judicial/ Ist Class Magistrate to the effect that:-
  - a. That incase any adverse report about Qualification, Date of Birth, Marks Certificates, Reserved Category certificate, Domicile Certificate etc, if any, is received from the concerned authority, I shall have no right to claim engagement as Junior Staff Nurse, as such shall be deemed to have been cancelled ab-initio.
