incorrect/false or suppressing material information shall render such person liable for legal action under law and his/her candidature shall be cancelled. In case such a defaulter is traced after selection, his/her contract shall be terminated.

- 3. The candidate(s) shall have to submit an affidavit duly attested by the Judicial/ Ist Class Magistrate to the effect that:
 - a. That in case any adverse report about Qualification, Date of Birth, Marks Certificates, Reserved Category certificate, Domicile Certificate etc, if any, is received from the concerned authority, the candidate(s) shall have no right to claim his/her engagement as such shall be deemed to have been cancelled ab-initio.
