Pursuant to the recommendation and approval from the selection committee endorsed by the Registrar Academics Govt. Medical College Anantnag and No Objection Certificate issued by the Administrative Department (Health & Medical Education Department) vide No. HD-Gaz0Gen/929/2023-02(E-7354250) dated 21.01.2025, **Dr Raja Ishfaq Rather S/O Ab Gani Rather R/O Dalwach Gagisgund Qazigund**, an in-service candidate, is provisionally engaged as Senior Resident in the Department of General Medicine, Govt. Medical College Anantnag, initially for a period of one year which is extendable upto (03) years on the basis of good performance to be certified by the concerned Head of Department.

## Terms and conditions:

- Before joining the Department, the selected candidate shall submit an undertaking in the office of the Registrar Academics, Govt. Medical College Anantnag duly attested by the Judicial Magistrate (1st Class) to the effect that:
  - a. If the information furnished by me in the application form is found wrong at any point of time, I shall be liable to be punished under rules including confiscation of the Registration of the Doctor.
  - b. I will not participate in any kind of strike during the period of my tenure engagement. In the event I proceeded on strike, my tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.
  - c. I shall remain disciplined during the tenure period, any kind of misconduct shall make me liable for termination without any prior notice.
  - d. I am not involved in any criminal activity nor is there is any FIR/Court case pending/registered against me in any criminal department or police station/Hon'ble Court.
  - e. My engagement is strictly provisional till the recipient of verification of documents/ testimonials and CID Verification. In case adverse report is received from CID, J&K, I shall not claim for engagement which shall be deemed to have been cancelled abinitio.
  - f. I shall not claim any Experience Certificate in case I leave Senior Resident-ship before completion of first six months.
  - g. I will not indulge in any private practice. In case I am found doing private practice my appointment shall be liable for termination without any notice.
- The candidate shall strictly ensure that they shall not leave the Department before the completion of tenure (six months), however abandoning/terminating after six months of the engagement in the specialty will require one-month prior notice on either side falling

which the salary shall not be paid for one month to the incumbent and shall be released on completion of sanctioned term.
