action under law and her candidature shall be cancelled. In case such a defaulter is traced after selection, her contract shall be terminated.

- The candidate shall have to submit an affidavit duly attested by the Judicial/ Ist Class Magistrate to the effect that:
  - a. That in case any adverse report about Qualification, Date of Birth, Marks Certificates, Reserved Category certificate, Domicile Certificate etc, if any, is received from the concerned authority, I shall have no right to claim my engagement as such & shall be deemed to have been cancelled ab-initio. I will not also claim for any dues from GMC Anantnag as well in that case.
  - b. I shall not claim for any regular appointment in the department.
  - c. I will not participate in any kind of strike during my tenure.
  - d. I shall remain disciplined during my tenure of service in the institute.
